Donors will be contacted for permission prior to their name being recognized. Any requests by donors to remain anonymous will be honoured.



Ways of Giving there are a variety of ways in which you can support St. Joseph's Villa:

Pledges over time - pledged gifts qualify for recognition upon receiving the first installment.

Legacy Gifts (Planned Giving) - deferred or estate gifts through wills/bequests, life insurance, securities, RRSPs, RRIFs, annuities. Ask for a copy of our Planned Giving Brochure, "Cornerstone" for more details on these and other planned giving opportunities.

In Memoria - donations received in memory of a deceased relative or friend. Where gifts received for an in memoriam total \$1,500 or more, the total of these gifts will be honoured at the appropriate level on the Donor Wall.

In Honour of - special occasions, achievements, birthdays, anniversaries, retirements, etc.

Designated Donations - for a specific purpose such as equipment, furniture, research, or programs.

Naming Opportunities - in accordance with our policy, buildings, wings and rooms, may be "named" in recognition of a specific gift. A list of naming opportunities is available from the Foundation office.
